Preface

Islam must be recognized as the religion of knowledge and education for the prosperity of mankind in this world and in the hereafter. The Holy Qur'an and Ahl al-Bayt emphasize on education and knowledge. Moreover, science and the scholars are acknowledged more than piety and pious persons. Based on the religious teachings, the human status is determined in accordance with one's level of knowledge and to the extent he acts upon his knowledge.
