Preface

Direct and unveiled encountering the reality and truth is one of man's most fundamental rights of which man can be deprive by no authority. Enemies of

Islam have made every effort to draw an unreal and fearful picture of this great religion for non-Muslims of the entire world in general and western world in particular in the recent decades.

A major reason for such determined, unprecedented efforts is that super powers have realized that Islamic teachings can stand against their unlimited greed for rapacity and sucking wealth and blood of the oppressed. That is why they made every direct and indirect effort to cause hatred against Islamic inasmuch as they showed it a horrible religion so that they may prevent truth-seekers from embracing Islam on the one hand and introduce such perspectives which have no relation with the true Islam and introduce some people either they have raised themselves or they have indirectly supported who have nothing to do but terrorism and intimidation as representatives of Islam on the other.
